of bonds has been regularly retired until there now remains unpaid thereon Twenty eight hundred bonds of the par value of one Thousand dollars each; and Whereas, the Gas Company did secure the said issue of bonds by a mortgage upon all of its property real, personal and mixed and wheresoever situated and of whatsoever consisting, including as well that property which was owner by the Gas company on the date it made the said mortgage as well as any additional property, Real, Personal or mixed, which it might thereafter acquire; and Whereas, the said mortgage contained a provision that if the Gas Company should thereafter acquire any additional property it would, upon demand of the trustee, by supplemental papers or deeds of assignment, convey and assign such additional and subsequently acquired property to the Trustee as additional security for the said bonds then remaining unpaid; and Whereas, the Gas Company has acquired the title to the property hereinafter described and demand has been made upon it that it execute properly written instrument or deed of assignment conveying the same to the Trustee as additional security for the said bonds, and subject to all the terms and conditions of the said mortgage, and the Gas Company desires to comply with such demand; Now Therefore, This Indenture Witnesseth; That in order to comply with the said demand and keep its covenants under the said mortgage and to secure the payment of the said, issue now remaining unpaid and in consideration of the premises and of the sum of one dollar to it well and truly paid by the Trustee at or before the ensealing and delivery hereof, the receipt whereof, is hereof, the receipt whereof is hereby acknowledged, the Gas company has Granted, Bargained, sold, aliened, enfeoffed, released, remised, conveyed, confirmed, assigned, transferred, set over pledged and mortgaged, and by these presents does grant, bargain, seil alien, enfeoff, release, remise, convey, confirm, assign, transfer, set over, pledge and mortgage unto the Trustee, the party of the second part, its successors and assigns in the trust by the said Mortgage created, and all of the following described property; First, All that certain gas transportation plant consisting of a system of pipe line which commence in Montgomery County, Kansas near the Oklahoma state line and run north and northeasterly to Kansas City, and St. Joseph, Missouri, Kansas city, Atchison, Leavenworth, Lawrence, and Topeke, Kansas, and eastwardly to Carthage, Joplin, Webb City and other points in Southwestern Missouri, and Pittsburg Galena, Oswego and other towns in Southeastern Kansas, together with all drips, valves reducers, meters, pumping or compressor stations and engines, appliances, fittings, equipment, fixture, structures, machinery and property belonging to or connected with the said pipe line plant or system, and all extentions, feeders, branch lines and gathering lines connected therewith. that portion of the said pipe line, which lies in Douglas County, Kansas, consisting of :-
