TO HAVE AND TO HOLD THE SAME, Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging, or in any wise appertaining, forever.

PROVIDED HOWEVER, And this instrument is executed and delivered to secure payment of the sum of Forty Two Hundred DOLLARS, with interest and premium thereon, and such fines and charges as may become due to said party of the second part under the terms and conditions of the contract note secured hereby, advanced by the said THE LAWRENCE BUILDING AND LOAN ASSOCIATION to the part 4 of the first part upon 3 1/2 shares of Class B of the capital stock of said Association, evidenced by Certificate No. 68, which said shares have been assigned to said Association with all future payments, earnings and dividends thereon, which said interest, premium and dues on said shares, the first part res agree to pay in monthly installments, making a total monthly payment of \$ 40.64, payable as follows: For 164/100 Dollars, (\$40.64) on or before the last day of April, 1912 and a like sum on or before the last day
