WITNESSETH, That the said party of the first part, in consideration of the sum of Five Hundred and Five & 50/100 Dollars the receipt of which is hereby acknowledged, does by these presents, grant, bargain, sell and convey unto said party of the second part, her heirs and assigns, all the following described real estate, situated in the County of Douglas and State of Kansas, to-wit:
