And the said Robert S. Lovett and Joseph Hellen being by me duly sworn, did severally depose and say that said Robert S. Lovett is and at the time of the execution of said instrument or mortgage deed was a vice president and that the said Joseph Hellen is and at the time of the execution of said instrument or mortgage deed was an Assistant Secretary of said Union Pacific Railroad Company the corporation named in the foregoing instrument that such instrument was signed on behalf of said corporation by authority of a resolution of its Board of Directors; that they knew the corporate seal of said Company; that the seal affixed to the foregoing instrument was and is the corporate seal of said Company, and that it was so affixed by order of the Board of Directors of the said Company, and that the said Robert S.
