WITNESSETH, that the said party of the first, for and in considerration of Two Hundred eight and no/100 Dollars, paid by said party of the second part, the receipt whereof is ereby acknowledged, has granted, bargained, sold and conveyed, and and by these presents dees grant, bargain, sell and convey, unto the said party of the second part, the following described real property situate in the County of Douglas and State of Kansas, to wit:

Lot twenty (20), block two (2), in Belmont, an addition to the city of Lawrence. Kansas as surveyed, platter and recorded. Subject to a first mortgage of Four Hundred Dollars (\$400) running to F. M. Perkins for material. together with all the tenements, hereditaments and appurtaneous to the same belonging, and all the estate, title, dower, right of homestead, claims and demands whatsoever of the said party of the first part of, in or to said premises or any part thereof; and said party of the first particles hereby covenant, that the said party of the first part is lawfully sizzed of "said, premises are free from incumbrances and that said party of the first part of the said bereform and defend the title to said premises against the lawfull claims and demands of said, premises whomsoever.

PROVIDED ALWAYS, and these presents are upon these conditions:

WHEREAS, said party of the first part has executed and delivered to said party of the second part One promissory note for Two hundred and eight dollars payable at the regular rate of fifty cents a week as per contract. and whereas, the party of the 2 first part has agreed to keep the buildings, if any, upon said premises, insured in some company or companies approved by said party of the second part for the sum of not less than\_\_\_\_\_\_ Dollars, and deliver to said party of the second part the policy or policies containing a clause with the loss payable to the porty of the second part. or assigns, and has agreed to pay all taxes and assessments against said premises before the same, by law, become delinquent; and has agreed that if said party of the fr before the same, by law, become definition, and has all out of the said party of the first part does not provide such insurance, or fails to pay all taxes as aforesaid, then said party of the second part, or holder hereof, may pay such insurance and taxes or either of them, and all camounts so paid by said party of the second part shall bear interest at the rate of ten per cent per annum from date of payment, and this mortgage shall stand security therefor, and said sum may be addedato the amount of the mortgage debt, and the same recovered as a part thereof. Now if the said party of the first part shall well and truly pay or cause to be paid the said sum of money in said note mentioned, with interest thereon according to the tengor and effect of said note and shall keep said buildings insured as aforesaid, and shall keep all taxes and assessments paid, and shall duly keep and perform all the other covenants and agreements herein contained, then these presents to be null and void. But if said sum of money or any part thereof or any interest thereon, is not paid when the same is due, or if said buildings shall not be kept insured as aforesaid, or if the taxes and assessments against said premises are not paid at or beforesthe time the same become by law delinquent or if said party of the first part shall fail to keep and perform any of the ants herein contained, the holder hereof shall have the option to declare the whole of said indebtedness due and payable at any time after such failure or default, and may maintain any action at law or equity to recover the same, and the commencement of such action shall be the only notice of the exercise of said option required.
