

9. A line of double track railroad extending from Summit to Lane, all in Douglas County, Nebraska, about 11.61 miles.

10. A line of railroad extending from Station 3 (Barriesville), Greeley Branch, to Southwest quarter of Section 28, Township 8, north of Range 63, West of the Sixth Principal Meridian, all in Weld County, Colorado, none of which is completed.

Main Track.

Additional main track a part or all of the distance between the following points: Valley, Douglas County, through Dodge County to Richland (formerly Benton), Colfax County, Nebraska; Columbus, Platte County, to Lookwood, Morrisk County, Nebraska; Alda, Hall County, to Ruda, Buffalo County, Nebraska; Watson's Ranch, Buffalo County, through Dawson, Lincoln, Keith and Deuel Counties, Nebraska; Sedgwick County, Colorado, and Cheyenne and Kimball Counties, Nebraska, to Pine Bluffs, Laramie County, Wyoming; Laramie County, through Carbon County, to Wamsutter, Sweetwater County, Wyoming; Point of Rocks, to Granger, all in Sweetwater County, Wyoming; Pullman, Denver County, Colorado, to Sand Creek, Adams County, Colorado.

Real Property.

Omaha, Douglas County, Nebraska.

Land for spur track 14th Street.

Plot of land of about 10.28 acres at Carter Lake, Park, situated in the northwest quarter of the west half of the northeast quarter of Section 2, and the northeast quarter of Section 3, in Township 15, north of Range 13, east of the Sixth Principal Meridian.
