This Indenture, Made this 30 day of Nov. A.D. 1914 between Harvey L. Goff and Myrtle L. Goff, his wife of Douglas County in the State of Kansas of the first part, and Stephen H. Hennessey of Douglas County in the State of Kansas of the second part: Witnesseth, That said part of the first part, in consideration of the sum of Five Hundred and no/100 Dollars, the receipt of which is hereby acknowledged, do by these presents grant, bargain, sell and convey unto said part of the second party heirs and assigns, all the following described Real estate, situate in Douglas County, and State of Kansas, to wit:

The Northwest Quarter (NW 1/4) of Section Six (6) in Township Twelve (12), South, Range Eighteen (18), east of the Sixth (6th) Principal Meridian, except a tract of land described as follows:

Beginning at the Northeast corner of said Quarter Section; thence South Twenty-eight and one half (28 1/2) rods; thence west Eighty-four (84) rods; thence North Twenty-eight and one half (28 1/2) rods; thence east Eighty-four and one half (84 1/2) rods to the place of beginning; and Also Seven acres described as follows: Beginning at the Southwest corner of Section Thirty-one (31) in Township Eleven (11), south, Range Eighteen (18), east of the Sixth (6th) Principal Meridian; running North Sixty-two (62) rods on the west line of said tract; thence east Eighteen (18) rods; thence South to south line of said tract; thence west on said line to beginning.

Subject to a prior mortgage for \$2000- and one for \$140.00 to the Farm Mortgage Co.

Now if said parties of the first part shall pay or cause to be paid to said party of the second part, his heirs or assigns, said sum of money in the above described note mentioned, together with the interest thereon, according to the terms and tenor of the same, then these presents shall be wholly discharged and void; and otherwise shall remain in full force and effect. But if said sum or sums of money, or any part thereof, or any interest thereon, is not paid when the same is due, or if the taxes and assessments of every nature which are or may be assessed and levied against said premises, or any part thereof, are not paid when the same are by law made due and payable, then the whole of said sums and interest thereon, shall, by these presents become due and payable, and the party of the second part shall be entitled to the possession of said premises.
