This Indenture, Mace this 10th day of December A.D. 1914, between Belle Ross, a single woman of Chicago and State of Illinois party of the first part, and Farmers Loan & Trust Company, a corporation under the laws of the State of Kansas, located at Law-rence, Kansas, Douglas County, Kansas, party of the Second part:

Witnesseth, That the said party of the first part, in consideration of the sum of Five Hundred Fifty and no/100 Dollars, in hand paid, the receipt whereof is hereby acknowledged, does hereby grant, burgain, sell and convey unto the said party of the second part, its successors and assigns, the following described real estate; situate in the County of Douglas and State of Kansas, to-wit:-

To Have And To Hold the same, with the appurtenances thereu to belonging or in anywise apparatining, including any right of homestead and every contingent right or estate therein, unto the said party of the second part, its successors or assigns for-ever; and the said party of the first part hereby covenants that not the delivery breef she is lawfully seized of said premises and has good right to convey the same; that said premises are tree and clear of all incumbrances; and that she will Warrant and Defend the same against the lawful claims of all persons whomsover,

Provided, However, That if the said party of the first part, shell pay or cause to be paid to the said party of the second part, its successors or assigns the princtpal sum of Five Hindred Fifty and no/100 Bollars, on the 100h day of annual 1917, with interest thereon at the rate of six per cent per annum, payable semi-annual 1917, with interest thereon at the rate of six per cent per annum, payable semi-annual sum of Five Hundred Fifty and no/100 Dollars, on the 10th day of December A.D. ly on the 10th days of June and Recember in each year, together with interest at the rate of ten per cent per annum on any installment of interest which shall not have been paid when 'due, and on said principal sum after the same becomes due or payable, according to the tenor and effect of a certain promissory note, and six coupon interest notes there to attached bearing even date herewith, executed by the said party of the first part and psyable to the party of the second part or its order at the office of said Company, in Lewrence, Kansas, or such other place as the legal holder of the actual loan from the party of the Sicond partitotth party of the first part; and shall perform all and singular the covenants have in contained; then this mortgege to be void, and to be released at the expense of the party of the first part, otherwise to remain in full force and effect. And the said party of the first part does hereby covenant and agree to pay, or

cause to be paid, the principal sum and interest above specified, in manner aforessid, together with all costs and expenses of collection, if any there shall be, and any costs, incurred and paid by the said party of the second part, its successors or assigns, in maintaining the priority of this mortgage; that the said party of the second part may make any payments necessary to remove or extinguish any prior or outstanding title, lien or incumbrance on the premises hereby conveyed, and any sums so paid shall become a lien upon the above described real estate and be secured oy this mortgage, and may be recovered with interest at ten per cent in any suit to foreclose this mortgage.

And the said party of the first part hereby further covenants and agree to pay all taxes, general or special, which may be assessed upon said land, premises or property; Also to abstain from the commission of waste on said premises, and to keep the buildings in good repair and insured to the emount of \$1,000.00 in insurance companies acto the said party of the second part, its successors or assigns, and to asceptable sign and deliver to it or them all policies on insurance on said buildings, and the renewals thereof; and in case of failure to do so, the said party of the second part, Alts successors or assigns, may pay such taxes and assessments, make such repairs, or offect such insurance, and the amounts paid therefore, with interest the reon from the date of payment, at the rate of ten personnt per annum, shall be collectible with as

a part of, and in the same manner as the principal sum hereby secured. N And the said party of the first part does further covenant and agree that in case of default in payment of any installment of interest, or in the performance of any of the covenants or agreements herein contained, then, or at any time thereafter during G the continuance of such default, the said party of the second part, its successors or assigns, may, without notice, declare the entire debt hereby secured immediately due and payable, and thereupon, or in case of default in payment of said promissory note at maturity, the said part; of the second part, its successors or essigns, shall be en titled to the immediate possession of said premises, by receiver or otherwise, as it may elec't, and to the subsequent rents and profits of said premises, which are hereby pledged to the legal holder hereof as additional and collateral security for the payment of all monies mentioned herein, and may proceed to foreclose this mortgage; and in case of foreclosure, the judgement rendered shall provide that the whole of said premises be sold together and not in parcels.
