

Mortgage Record.

This Indenture, Made this Winterset day of January in the year of our Lord one thousand nine hundred and fourteen between Mary Smith (w) Fred C. Smith (husband) of Leominster in the County of Douglas and State of Kansas, of the first part, and President of Board Trustees of Kansas Yearly Meeting of Friends a Corporate Body of the second part:

WITNESSETH, That the said part us of the first part, in consideration of the sum of Twenty six hundred DOLLARS to them duly paid, the receipt of which is hereby acknowledged, have sold, and by these presents do grant, bargain, sell and mortgage to the said part us of the second part, his heirs and assigns forever, all that tract or parcel of land situated in the County of Douglas and State of Kansas, described as follows to wit:

West fractional half (1/2) of North West Quarter (1/4) of Section No. Three (3) Township No. Twelve (12) Range No. Eighteen (18)

with the appurtenances, and all the estate, title and interest of the said part us of the first part therein. And the said Mary Smith (w) Fred C. Smith do hereby covenant and agree that at the delivery hereof they are the lawful owner of the premises above granted and seized of a good and indefeasible estate of inheritance therein, free and clear of all incumbrances, and that they will warrant and defend the same against all claims whatsoever. This grant is intended as a Mortgage to secure the payment of the sum of Twenty six hundred DOLLARS,

according to the terms of one certain promissory note Mary Smith (w) Fred C. Smith this day executed by the said Mary Smith (w) Fred C. Smith to the said part us of the second part; said note being given for the sum of Twenty six hundred DOLLARS,

dated January 13th 1914, due and payable in five year 9 from date thereof, with interest thereon from the date thereof until paid according to the terms of said note and in coupons of twenty eight dollars each thereto attached. And this conveyance shall be void if such payment be made as in said note and coupons thereto attached, and as hereinafter specified. And the said part us of the first part hereby agree to pay all taxes assessed on said premises before any penalties or costs shall accrue on account thereof, and to keep the said premises insured in favor of said mortgagee, in the sum of One thousand DOLLARS,

in some insurance company satisfactory to said mortgagee, in default whereof the said mortgagee may pay the taxes and accruing penalties, interests and costs, and insure the same at the expense of the part us of the first part, and the expense of such taxes and accruing penalties, interest and costs, and insurance, shall, from the payment thereof, be and become an additional lien under this mortgage upon the above described premises, and shall bear interest at the rate of 10 per cent. per annum. But if default be made in such payment, or any part thereof or interest thereon or the taxes assessed on said premises or if the insurance is not kept up thereon, then this conveyance shall become absolute, and the whole principal of said note, and interest thereon, and all taxes and accruing penalties and interest and costs remaining unpaid or which may have been paid by the part us of the second part, and all sums paid by the part us of the second part for insurance, shall be due and payable or not, at the option of the part us of the second part, and it shall be lawful for the part us of the second part, his executors, administrators or assigns, at any time thereafter, to sell the premises hereby granted, or any part thereof, in the manner prescribed by law, appraisement hereby waived or not, at the option of the part us of the second part, and executors, administrators or assigns, and out of all the moneys arising from such sale to retain the amount then due or to become due according to the conditions of this instrument, together with the costs and charges of making such sale, and the overplus, if any there be, shall be paid by the part us making such sale, on demand, to the said Mary Smith heirs and assigns.
