Sixth .- Incosse of default of payment of any sum barein covenanted to be paid, for the period of thirty days after the same becomes due, or in default of performance for the period of whith any alter the same becomes due, or in defailt of performance of any covenant herein contained, the said first party agrees to pay to the said second party or assigns, interest at the rate of ten per cent per annum, computed annually on said principal note, from the date thereof to the time when the money shall be actually paid. Any payment made on account of interest shall be credited in said com-putation so that the total amount of interest, shall be, and not exceed, the legal rate
