erest moneys hereby secured when and as the same shall become due and payable, without deduction for any taxes, rates or governmental charges of any kind, any and all which said taxes, rates or governmental charges upon the own ership of the party of the second part hereto, or upon the Notes or indebtedness secured hereby shall be paid by the party of the first part;
