This Indenture, Made this 16<sup>th</sup> day of March in the year of our Lord Nineteen hundred eighteen (1918), between Henry G. Van Neste & Dora E. Van Neste, husband and wife of near Lawrence in the County of Douglas, and State of Kansas, of the first part, and

Charles Benson Strong of the second part:

WITNESSETH, That the said part ies of the first part, in consideration of the sum of Seven Thousand (\$7000.00) and 950 DOLLARS,

to them duly paid, the receipt of which is hereby acknowledged, has been sold, and by these presents do grant, bargain, sell and mortgage to the said part of of the second part his heirs and assigns, forever, all that tract or parcel of land situated in the County of Douglas, and State of Kansas, described as follows, to wit: The South Forty-six (46) acres of the Northeast Quarter (4<sup>th</sup>) of section Sixteen (16), and the North half (1/2) of the Southeast Quarter (4<sup>th</sup>) Section Sixteen (16), and the West Two (2) rods in width across the whole West end of the South half (1/2) of the South East Quarter (4<sup>th</sup>) of Section Sixteen (16), containing one (1) acre, all in Township Twelve (12), Range Twenty (20), in Douglas County, Kansas.

also, in Leavenworth County, Kansas. Beginning at a stone in the West boundary of Section Sixteen (16) of Township Twelve (12) South of Range Twenty (20) East of the C.R.R.M., twenty three chains and forty links (23ch. 40L.) But if default be made in such payment, or any part thereof, or interest thereon, or the taxes, or if the insurance is not kept up thereon, then this conveyance shall become absolute, and the whole amount shall become due and payable, and it shall be lawful for the said part of of the second part his executors, administrators and assigns, at any time thereafter to sell the premises hereby granted, or any part thereof, in the manner prescribed by law; and out of all the moneys arising from such sale to retain the amount then due for principal and interest, together with the cost and charges of making such sale, and the overplus, if any there be, shall be paid by the part of making such sale, on demand, to said Henry G. Van Neste his heirs and assigns.
