 the receipt of which is hereby acknowledged, do se by these presents grant, bargain, sell and convey, unto said party of the second part, its successors and

assigns, all of the following described real estate, situated in the County of Douglas, and State of Kansas, to-wit:

Lots Numbers Eighteen (18) and Nineteen (19) in Block Number
Nineteen (19) in Lawrence Second Addition to the City of Lawrence,

TO HAVE AND HOLD THE SAME, Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging, or in
 any wise appertaining, forever.

PROVIDED ALWAYS, And this instrument is executed and delivered to secure payment of the sum of

Fifteen hundred and no/100 DOLLARS,
 with interest and premium thereon, and such fines and charges as may become due to said party of the second part under the terms and conditions of the con-
 tract note secured hereby, advanced by the said THE Lawrence BUILDING AND LOAN ASSOCIATION to the party of the first
 part upon 18 shares of Class Common of the capital stock of said Association, evidenced by Certificate No. 221 which said
 shares have been assigned to said Association with all future payments, earnings and dividends thereon, which said interest, premium and dues on said
 shares, the first party agrees to pay in monthly installments, making a total monthly payment of \$ 19.05, payable as follows: 1916
Written and No Dollars, (\$ 19.05) on or before the last day of June 1916
 and a like sum on or before the last day of each and every month thereafter to and including the month of May 1926
