

MORTGAGE RECORD

WITNESSETH: That the party of the first part, in consideration of the sum of

Five hundred and no/100 Five hundred and no/100 DOLLARS,
the receipt of which is hereby acknowledged, do by these presents grant, bargain, sell and convey, unto said party of the second part, its successors and

assigns, all of the following described real estate, situated in the County of Douglas, and State of Kansas, to-wit:

The West Forty-two (42) feet of Lot Number One hundred Sixty Five (165) Kentucky Street in the City of Lawrence, County of Douglas, State of Kansas.

TO HAVE AND HOLD THE SAME, Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging, or in any wise appertaining, forever.

PROVIDED ALWAYS, And this instrument is executed and delivered to secure payment of the sum of Five hundred and no/100 DOLLARS,

with interest and premium thereon, and such fines and charges as may become due to said party of the second part under the terms and conditions of the contract note secured hereby, advanced by the said Lawrence BUILDING AND LOAN ASSOCIATION to the party of the first part upon five shares of Class AAA of the capital stock of said Association, evidenced by Certificate No. 2325 which said shares have been assigned to said Association with all future payments, earnings and dividends thereon, which said interest, premium and dues on said shares the first part do agree to pay in monthly installments, making a total monthly payment of \$ 6.35 Dollars, (\$ 6.35) on or before the last day of January 1917 and a like sum on or before the last day of each and every month thereafter to and including the month of December 1926

Now, if said party of the first part shall cause to be paid to the party of the second part the amount due it under said contract note, in accordance with the terms thereof, and comply with all the provisions and agreements in said note contained, then these presents shall be void; otherwise in full force and effect, and may be foreclosed as in said contract note provided.
