WITNESSETH: That the party of the first part, in consideration of the sum of
Two Hundred Fifty and no/100 DOLLARS,
 the receipt of which is hereby acknowledged, do sell by these presents grant, bargain, sell and convey, unto said party of the second part, its successors and

assigns, all of the following described real estate, situated in the County of Douglas, and State of Kansas, to-wit:
Lot Number One Hundred Eight (108) on Indiana Street in
Block Number Forty (40) in that part of the City of Lawrence known
as West Lawrence

TO HAVE AND HOLD THE SAME, Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging, or in
 any wise appertaining, forever.

PROVIDED ALWAYS, And this instrument is executed and delivered to secure payment of the sum of
Two Hundred and no/100 DOLLARS,
 with interest and premium thereon, and such fines and charges as may become due to said party of the second part under the terms and conditions of the con-
 tract note secured hereby, advanced by the said THE Lawrence BUILDING AND LOAN ASSOCIATION to the party of the first
 part upon 25 shares of Class 6 of the capital stock of said Association, evidenced by Certificate No. 217 which said
 shares have been assigned to said Association with all future payments, earnings and dividends thereon, which said interest, premium and dues on said
 shares, the first party agrees to pay in monthly installments, making a total monthly payment of \$ 7.95, payable as follows
Seven and 95/100 Dollars, (\$ 7.95) on or before the last day of March 1922
 and a like sum on or before the last day of each and every month thereafter to and including the month of February 1923.
