This Indenture Made this 2nd day of September A. D. 1922, between
E. H. Miller, single

WITNESSETH: That the party of the first part, in consideration of the sum of

Five Hundred and no/100 DOLLARS,
 the receipt of which is hereby acknowledged, does by these presents grant, bargain, sell and convey, unto said party of the second part, its successors and

assigns, all of the following described real estate, situated in the County of Douglas, and State of Kansas, to-wit:

Lot Number One Hundred Seven (107) on Connecticut Street
in the City of Lawrence, Kansas

TO HAVE AND HOLD THE SAME, Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging, or in
 any wise appertaining, forever.

PROVIDED ALWAYS, And this instrument is executed and delivered to secure payment of the sum of

Five Hundred and no/100 DOLLARS,
 with interest and premium thereon, and such fines and charges as may become due to said party of the second part under the terms and conditions of the con-
 tract note secured hereby, advanced by the said THE Douglas County BUILDING AND LOAN ASSOCIATION to the part of the first
 part upon 5 shares of Class 6 of the capital stock of said Association, evidenced by Certificate No. 3072, which said
 shares have been assigned to said Association with all future payments, earnings and dividends thereon, which said interest, premium and dues on said
 shares, the first part 4 agreed to pay in monthly installments, making a total monthly payment of \$ 15.90, payable as follows:
Fiftieth and 30/100 Dollars, (\$ 15.90) on or before the 15th day of September 1922
 and a like sum on or before the 2nd day of each and every month thereafter to and including the month of August 1923

Now, if said part of the first part shall cause to be paid to the party of the second part the amount due it under said contract note, in accordance
 with the terms thereof, and comply with all the provisions and agreements in said note contained, then these presents shall be void; otherwise in full force
 and effect, and may be foreclosed as in said contract note provided.
