This Indenture, made this Fourteenth day of April in the year of our Lord nineteen hundred and twenty between Wilson H. Clark and Neta Clark his wife of the city of Lawrence in the County of Douglas and State of Kansas, of the first part, and

J. M. Elliott

of the second part:

WITNESSETH That the said parties of the first part, in consideration of the sum of Eighteen Hundred Dollars,

to them duly paid, the receipt of which is hereby acknowledged, have sold, and by these presents do grant, bargain, sell and mortgage to the said party of the second part her heirs and assigns, forever, all that tract or parcel of land situated in the County of Douglas, and State of Kansas, described as follows, to wit: commencing at the Southwest corner of the North East Quarter (1/4) acre of North Fifteen (15) acres of the Northwest Nineteen (19) acres of the Northwest quarter (1/4) of the Southeast quarter (1/4) of Sections Six (6) in Township Thirteen (13) of Range Twenty (20), thence East parallel with the North line of said quarter section One hundred and eighty-two (182) feet to the garden fence as now located on said tract; thence North parallel with the West line of said quarter section Fifty (50) feet, thence West One hundred and eighty-two (182) feet to the said west line of said quarter section; thence South Fifty (50) feet to the place of beginning, together with the dwelling house and other improvements thereon, erected thereon, being numbered Seventy-five (75) on Delaware Street in the City of Lawrence, and lot number Seventy-five (75) on Delaware Street in City of Lawrence, in said County of State, with all the appurtenances, and all the estate, title and interest of the said parties of the first part therein. And the said

parties of the first part do hereby covenant and agree that at the delivery hereof they will be the lawful owners of the premises, above granted, and seized of a good and indefeasible estate of inheritance therein, free and clear of all incumbrances

This Grant is intended as a Mortgage to secure the payment of the sum of Eighteen Hundred Dollars

according to the terms of and certain Note this day executed and delivered by the said parties of the first part to the said party of the second part payable five years after date with interest thereon according to the terms of said note and coupons thereto attached

and this conveyance shall be void if such payments be made as herein specified. But if default be made in such payment or any part thereof, or interest thereon, or the taxes, or if the insurance not kept up thereon, then this conveyance shall become absolute, and the whole amount shall become due and payable, and it shall be lawful for the said party of the second part, her executors, administrators and assigns, at any time thereafter to sell the premises hereby granted, or any part thereof, in the manner prescribed by law; and out of all the moneys arising from such sales to retain the amount then due for principal and interest, together with the cost and charges of making such sale, and the overplus, if any there be, shall be paid by the party of the first part making such sale, on demand, to said parties of the first part their heirs and assigns.
