This Indenture, Made this 30th day of April in the year of our Lord nineteen hundred Twenty between Wm Greff Jr. and Mrs. Ann Greff, his wife of Eudora in the County of Douglas and State of Kansas, of the first part, and The State Bank of Eudora, Eudora, Mo. (A Corporation) of the second part:

WITNESSETH That the said parties of the first part, in consideration of the sum of One thousand and no/100 DOLLARS, to them duly paid, the receipt of which is hereby acknowledged, he was sold, and by these presents do we grant, bargain, sell and mortgage to the said part y of the second part its successors heirs and assigns, forever, all that tract or parcel of land situated in the County of Douglas, and State of Kansas, described as follows, to wit: Lot Number (5) Five in Block Number One hundred and forty five (145) City of Eudora, County and State of Kansas.

with all the appurtenances, and all the estate, title and interest of the said part is of the first part therein. And the said Wm Greff Jr. and Mrs. Ann Greff, his wife do we hereby covenant and agree that at the delivery hereof they are the lawful owners of the premises, above granted, and seized of a good and indefeasible estate of inheritance therein, free and clear of all incumbrances

This Grant is intended as a Mortgage to secure the payment of the sum of Dollars

according to the terms of one certain note this day executed and delivered by the said Wm Greff Jr. and Mrs. Ann Greff to the said part y of the second part due and payable two years after date with interest at the rate of 6% per annum, payable semi-annually, at the State Bank of Eudora, Eudora, Mo. and this conveyance shall be void if such payments be made as herein specified. But if default be made in such payments or any part thereof, or interest thereon, or the taxes, or if the insurance is not kept up thereon, then this conveyance shall become absolute, and the whole amount shall become due and payable, and it shall be lawful for the said part y of the second part, its executors, administrators and assigns, at any time thereafter to sell the premises hereby granted, or any part thereof, in the manner prescribed by law; and out of all the moneys arising from such sales to retain the amount then due for principal and interest, together with the cost and charges of making such sales, and the overplus, if any there be, shall be paid by the part y making such sale, on demand, to said Wm Greff Jr. and Mrs. Ann Greff, his wife their heirs and assigns.
