In the 28 day executed and delivered 1923 certain promissory note in writing to said part of the second part, of which the following
is for the sum of - Twelve Hundred Dollars - being even date herewith
payable at Baldwin State Bank, Baldwin City, Kansas, in equal installments
of Twenty Five Dollars each, the first installment payable on the 28 day of May, 1923, the
second installment on the 28 day of June, 1923 and one installment on the 28 day of each
month in each year thereafter until the entire sum is fully paid. And if default be
made in the payment of any one of said installments when due, or any part thereof, then
all unpaid installments shall become immediately due and payable at the time of the part of the
second part or the legal holder of said note, and shall draw interest at the rate of 10 per
cent per annum from the date of said note until fully paid. Appraisement waived
