Witnesseth, That said part of the first part, in consideration of the sum of

Thirteen hundred and no/100 DOLLARS,

the receipt of which is hereby acknowledged, do by these presents, grant, bargain, sell and convey unto said parties of the second part, their heirs and assigns, all the following described REAL ESTATE, situated in the County of Douglas County, and State of Kansas, to wit:

The east Sixty acre of south east quarter (64th), and south twenty acres of the west one hundred acre of south east quarter (SE^{1/4}), section seven, township thirteen, range eighteen, containing eighty acres of land more or less, being beginning at the south west corner of section eight, thence north to center of channel of Dry Branch Creek, easterly along said center approximately sixty rods, thence south about forty rods to a south line of said section, thence west to beginning, section eight, township thirteen, range eighteen, containing twenty-four acres of land more or less.

Now, If said part of the first part shall pay or cause to be paid to said part of the second part, their heirs or assigns, said sum of money in the above described note mentioned, together with the interest thereon, according to the terms and tenor of the same, then these presents shall be wholly discharged and void; and otherwise shall remain in full force and effect. But if said sum or sums of money, or any part thereof, or any interest thereon, is not paid when the same is due, and if the taxes and assessments of every nature which are or may be assessed and levied against said premises or any part thereof, are not paid when the same are by law made due and payable; then the whole of said sum and sums and interest thereon, shall, and by these presents, become due and payable and said part of the second part shall be entitled to the possession of said premises.
