payment, notice of non-payment, protest and notice of protest and diligence of bringing suit against any party thereto,  
and consent that time of payment may be extended without notice thereof to any of the parties of this note. Privilege is  
granted to pay any amount at any time.  
Due Sec. by REM, P.O. Decompton, Ks. William E. Ice  
Bessie A. IceNow, If said parties of the first part shall pay or cause to be paid to said party of the second part, his heirs or assigns, said sum of money  
in the above described note xxx mentioned, together with the interest thereon, according to the terms and tenor of the same, then these presents shall be wholly discharged  
and void; and otherwise shall remain in full force and effect. But if said sum or sums of money, or any part thereof, or any interest thereon, is not paid when the same is due,  
and if the taxes and assessments of every nature which are or may be assessed and levied against said premises or any part thereof, are not paid when the same are by law made
