

MORTGAGE RECORD NO. 60

This Indenture, Made this Ninth day of May in the year of our Lord one thousand two hundred twenty one (1921), between Charles A. Farrell and Herman A. Farrell, his wife, and Ralph B. Farrell, a single man of Douglas County, Kansas in the County of Douglas and State of Kansas, of the first part, and Esau B. Farrell of Douglas County, Kansas of the second part:

WITNESSETH That the said parties of the first part, in consideration of the sum of Five thousand two hundred twenty four (\$5,224.00) DOLLARS, to them duly paid, the receipt of which is hereby acknowledged, have sold, and by these presents do grant, bargain, sell and mortgage to the said party of the second part his heirs and assigns, forever, all that tract or parcel of land

situated in the County of Douglas, and State of Kansas, described as follows, to wit: the East half (1/2) of the South East Quarter (1/4) of Section 11 (16), Township 13 North, Range 21 East, (21) East of the following described tract of land to-wit: Commencing at the North East corner of the said South East Quarter (1/4) of Section 11, thence South eight rods, thence South forty-five rods, thence East eight rods, thence North on the section line forty-five rods to place of beginning,

with all the appurtenances, and all the estate, title and interest of the said parties of the first part therein. And the said parties of the first part do hereby covenant and agree that at the delivery hereof they are the lawful owner se of the premises, above granted, and seized of a good and indefeasible estate of inheritance therein, free and clear of all incumbrances except a certain mortgage of \$5,000 to Fred B. Bremer recorded in Book 57, page 228, records of Douglas County, Kansas.

This Grant is intended as a Mortgage to secure the payment of the sum of Five thousand two hundred twenty four (\$5,224.00) according to the terms of an certain promissory note this day executed and delivered by the said parties of the first part to the said party of the second part payable as follows: before three years from date with interest at the rate of six per cent per annum, payable semi-annually.

and if default be made in such payments or any part thereof, or interest thereon, or the taxes, or if the insurance is not kept up thereon, then this conveyance shall become absolute, and the whole amount shall become due and payable, and it shall be lawful for the said party of the second part, his executors, administrators and assigns, at any time thereafter to sell the premises hereby granted, or any part thereof, in the manner prescribed by law; and out of all the moneys arising from such sale to retain the amount then due for principal and interest, together with the cost and charges of making such sale, and the overplus, if any there be, shall be paid by the party making such sale, on demand, to said parties of the first part within heirs and assigns.
