This Indenture, Made this fourth day of April in the year of our Lord nineteen hundred and twenty two between James L. Brown and Edith B. Brown his wife of Laurance in the County of Douglas and State of Kansas, of the first part, and J. L. Stanton of the second part

WITNESSETH That the said part 66.5 of the first part, in consideration of the sum of Twenty Two Hundred (\$22000) DOLLARS, to them duly paid, the receipt of which is hereby acknowledged, he has sold, and by these presents do grant, bargain, sell and mortgage to the said part 2 of the second part them heirs and assigns, forever, all that tract or parcel of land situated in the County of Douglas, and State of Kansas, described as follows, to wit: Lot number Two hundred twenty two (202) Lawrence Street Lawrence, Kansas

with all the appurtenances, and all the estate, title and interest of the said part all of the first part therein. And the said James L. Barron and Elith B. Barron his wife do they are hereby covenant and agree that at the delivery hereof they are the lawful owner is of the premises, above granted, and seized of a good and indefeasible estate of inheritance therein, free and clear of all incumbrances.

But if default be made in such payment, or any part thereof, or interest thereon, or the taxes, or if the insurance is not kept up thereon, then this conveyance shall become absolute, and the whole amount shall become due and payable, and it shall be lawful for the said party of the second part, James L. Smith, executor, administrators and assigns, at any time thereafter to sell the premises hereby granted, or any part thereof, in the manner prescribed by law; and out of all the moneys arising from such sales to retain the amount then due for principal and interest, together with the cost and charges of making such sales, and the overplus, if any there be, shall be paid by the party of the second part, James L.
