WITNESSETH: That the party of the first part, in consideration of the sum of One Thousand and no/100 DOLLARS, the receipt of which is hereby acknowledged, do.....by these presents grant, bargain, sell and convey, unto said party of the second part, its successors and assigns, all of the following described real estate, situated in the County of Douglas, and State of Kansas, to-wit:.....

Beginning at the southeast corner of said quarter section No. 36 Township 2 North Range 10 West; (10) 92.5 Paces east of the corner of said quarter section Thence North 27.6 Pace; Thence East 48.5 Paces more or less to the center of said bearing north and south through the south half of said quarter section; Thence north along the center of said road 29.6 Paces to the south line of said quarter section; Thence East 48.5 Paces more or less to the point of beginning containing several acres more or less

TO HAVE AND HOLD THE SAME, Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging, or in any wise appertaining, forever.

PROVIDED ALWAYS, And this instrument is executed and delivered to secure payment of the sum of

One thousand and no/100 DOLLARS,
with interest and premium thereon, and such fines and charges as may become due to said party of the second part under the terms and conditions of the
contract note secured hereby, advanced by the said 'THE Samuel BUILDING AND LOAN ASSOCIATION to the part of the first
part upon 100 shares of Class B of the capital stock of said Association, evidenced by Certificate No. 446, which said
shares have been assigned to said Association with all future payments, earnings and dividends thereon, which said interest, premium and dues on said
shares, the first part do agree to pay in monthly installments, making a total monthly payment of \$ 18.30, payable as follows:
Twelve and 30/100 Dollars, (\$ 12.72) on or before the last day of February
and a like sum on or before the 1st day of each and every month thereafter to and including the month of January

Now, if said part of of the first part shall cause to be paid to the party of the second part the amount due it under said contract note, in accordance with the terms thereof, and comply with all the provisions and agreements in said note contained, then these presents shall be void; otherwise in full force and effect, and may be foreclosed as in said contract note provided.
