

MORTGAGE RECORD

This Indenture, Made this 11th day of July A. D. 1922, between
Jella Lamb, a single woman

of Douglas County, in the State of Kansas, of the first part, and THE Douglas County BUILDING AND LOAN ASSOCIATION,
 of LAWRENCE, KANSAS, of the second part:

WITNESSETH: That the part of the first part, in consideration of the sum of
Twenty Five Hundred and no DOLLARS,
 the receipt of which is hereby acknowledged, do ed by these presents grant, bargain, sell and convey, unto said party of the second part, its successors and
 assigns, all of the following described real estate, situated in the County of Douglas, and State of Kansas, to-wit:

Beginning at a point on the west line of Kentucky Street
forty feet South of the Southeast corner of Block Seven (7) in
Patcocks Addition to the City of Lawrence, thence South seventy
five feet, thence West one hundred and seventeen feet, thence
North seventy five feet, thence East one hundred and seventeen
feet to the place of beginning.

TO HAVE AND HOLD THE SAME, Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging, or
 in any wise appertaining, forever.

PROVIDED ALWAYS, And this instrument is executed and delivered to secure payment of the sum of Twenty five hundred and no DOLLARS,
 with interest and premium thereon, and such fines and charges as may become due to said party of the second part under the terms and conditions of the
 contract note secured hereby, advanced by the said Douglas County BUILDING AND LOAN ASSOCIATION to the part of of the first
 part upon 25 shares of Class 2 of the capital stock of said Association, evidenced by Certificate No. 3127, which said
 shares have been assigned to said Association with all future payments, earnings and dividend's thereon, which said interest, premium and dues on said
 shares, the first part do agree to pay in monthly installments, making a total monthly payment of \$ 31.25, payable as follows:
Thirty One Dollars, (\$ 31.25) on or before the last day of July 1922
 and a like sum on or before the 11th day of each and every month thereafter to and including the month of June 1923

Now, if said part of of the first part shall cause to be paid to the party of the second part the amount due it under said contract note, in accordance
 with the terms thereof, and comply with all the provisions and agreements in said note contained, then these presents shall be void; otherwise in full force
 and effect, and may be foreclosed as in said contract note provided.
