the receipt of which is hereby acknowledged, do all by these presents grant, bargain, sell and convey, unto said party of the second part, its successors and

TO HAVE AND HOLD THE SAME, Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging, or

PROVIDED ALWAYS, And this instrument is executed and delivered to secure payment of the sum of

Two Thousand and no DOLLARS,

with interest and premium thereon, and such fines and charges as may become due to said party of the second part under the terms and conditions of the

contract note secured hereby, advanced by the said THE Douglas County BUILDING AND LOAN ASSOCIATION to the part of of the first

part upon 20 shares of Class E of the capital stock of said Association, evidenced by Certificate No. 3131 which said

shares have been assigned to said Association with all future payments, earnings and dividends thereon, which said interest, premium and dues on said

shares, the first part of agreed to pay in monthly installments, making a total monthly payment of \$ 41.40, payable as follows:

and a like sum on or before the 30 day of each and every month thereafter to and including the month of July 1927
