the receipt of which is hereby acknowledged, do by these presents grant, bargain, sell and convey, unto said party of the second part, its successors and assigns, all of the following described real estate, situated in the County of Douglas, and State of Kansas, to-wit:

The East Sixty-two Feet of Lot Number Fifty Seven (67) on New York Street in the City of Lawrence

TO HAVE AND HOLD THE SAME, Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging, or in any wise appertaining, forever.

PROVIDED ALWAYS, And this instrument is executed and delivered to secure payment of the sum of

Eight Hundred and no/100

DOLLARS,

with interest and premium thereon, and such fines and charges as may become due to said party of the second part under the terms and conditions of the contract note secured hereby, advanced by the said THE Lawrence BUILDING AND LOAN ASSOCIATION to the part of the first

part upon 8 shares of Class 6 of the capital stock of said Association, evidenced by Certificate No. 488 which said

shares have been assigned to said Association with all future payments, earnings and dividends thereon, which said interest, premium and dues on said

shares, the first partial agree to pay in monthly installments, making a total monthly payment of \$10.16, payable as follows: 1st

and 14/100 Dollars, (\$10.16) on or before the last day of September 1922

and a like sum on or before the 1st day of each and every month thereafter to and including the month of August 1922

Now, if said part of the first part shall cause to be paid to the party of the second part the amount due it under said contract note, in accordance
