

thence in a southerly direction through sections 10 and 2 and to the center of section 15, township 23 north, range 2 west, in Noble County, Oklahoma, with a lateral west to Washburn Pump Station, thence from the center of section 15 in a southerly direction to the southeast quarter of said section 15, with a lateral line to the Pillings Camp, thence in a southeasterly direction through section 22 to the 55,000 barrel storage tanks, thence in a southwesterly direction to the Power Plant at the southquarter corner of Section 22, township 23 north, range 2 west, end of line in Noble County, Oklahoma.

## C.

## The Milliken Refinery.

The entire leasehold estate created by lease dated July 13th, 1920 from the Milliken Company, a Delaware Corporation, to the Company, demising the plant known as The Milliken Refinery in Arkansas City, Kansas, located on the following described real estate to wit:

Beginning at a state monument marking the center of Section 36, township 34 south range 3 east of the 6th P.M. thence north along the north and south center line of said section 36, a distance of 2640.7 feet to a stone monument marking the northeast corner of northwest quarter of said section 36, thence westerly making an angle of 89 degrees, 18 minutes to the left with last described course a distance of 2400 feet; thence southerly making an angle of 90 degrees 42 minutes to the left with the last described course a distance of 2200 feet; thence easterly making an angle of 89 degrees 18 minutes to the left with last described course a distance of 1200 feet; thence southerly making an angle of 89 degrees 18 minutes to the right with the last described course a distance of 1045 feet; thence easterly making an angle of 89 degrees 18 minutes to the left with the last described course a distance of 1200 feet to the north and south center line of said section 36, thence north making an angle of 90 degrees 42 minutes to the left with last described course a distance of 6043 feet to beginning, in Cowley County, Kansas, together with a six inch oil pipe line known as the Ohkan Pipe Line, about 18 miles in length, running southwesterly from said refinery to a point in the northwest fourth of the northwest quarter of section 6, township 28 north, range 1 east, in Kay County, Oklahoma, and there connecting with a certain pipe line owned and operated by the Midco Transportation Company and known as the Mayhew-Milliken Pipe Line, in and by which said lease the Company is also given the right to use 469 tank cars and all tanks, pumping stations and other equipment connected with the operation and maintenance of said refinery and of said Ohkan Pipe Line.

## Third.

Also any and all rights of way, grants, consents, licenses, easements, leases and leasehold interests whatsoever, and all buildings, power houses and plants and the contents thereof located upon any of the real estate above described, together with all engines, boilers, derricks, rigs, casings, tools, drills, tubing, pipe lines, pumps, tanks, tank cars, machinery, fixtures, appliances or other equipment and appurtenances of every nature whatsoever now owned or hereafter to be acquired, located upon said real estate, or in any way used in connection with the development and operation of the same for oil and gas mining purposes.

## Fourth.

Also twenty four certain principal promissory notes of Midco Gasoline Company, a corporation of Oklahoma, all dated November 1, 1920, and numbered 1 to 24, both inclusive, note No. 1 being for the principal sum of Three Hundred Twenty Thousand Dollars (\$320,000.00) payable to bearer on November 1, 1921, and notes Nos. 2 to 24, both inclusive, being for the principal sum of One Hundred Sixty Thousand Dollars (\$160,000.00) each, and payable to bearer on respectively February 1, 1922, and quarterly thereafter, said note No. 24 being payable on August 1, 1927, with interest on all of said notes at the rate of eight per cent. per annum payable quarterly on the first days of February, May, August and November in each year until paid. All payments, both of principal and interest, upon said notes, are guaranteed by M.M. Travis and Midco-Mexico Petroleum Co., and are required to be made at the office of Continental and Commercial Trust and Savings Bank in the City of Chicago, Illinois, in gold coin of the United States of or equal to the Standard of weight and fineness existing on November 1, 1920.

The payment of said notes, together with the interest thereon, is secured by a Trust Deed dated November 1, 1920, from said Midco Gasoline Company to Continental and Commercial Trust and Savings Bank, a corporation of Illinois, and William P. Kopf of Chicago, Illinois, as Trustees, conveying all of the property of said Midco Gasoline Company, real and personal, and whether now owned or hereafter acquired; and said twenty four notes, aggregating the sum of Four Million Dollars (4,000,000.00), together with said Trust Deed securing the payment thereof, are hereby pledged by the Company to the Trustees hereunder as additional security for the full payment of the bonds and all other indebtedness secured to be paid by the terms of this Indenture.

## Fifth.

Also twenty four certain principal promissory notes of Midco Transportation Company, a corporation of Oklahoma, all dated November 1, 1920, and numbered 1 to 24, both inclusive, note No. 1 being for the principal sum of Eighty Thousand Dollars (\$80,000.00) payable to bearer on November 1, 1921, and notes Nos. 2 to 24, both inclusive, being for the principal sum of Forty Thousand Dollars (40,000.00) each, and payable to bearer on respectively February 1, 1922, and quarterly thereafter, said note No. 24 being payable on August 1, 1927, with interest on all of said notes at the rate of eight per cent. per annum, payable quarterly on the first days of February, May, August and November in each year until paid. All payments, both of principal and interest upon said notes, are guaranteed by M. M. Travis and Midco-Mexico Petroleum Co., and are required to be made at the office of Continental and Commercial Trust and Savings Bank in the City of Chicago, Illinois, in gold coin of the
