Second: To keep all buildings, fences and other improvements upon said premises in as good repair and condition as the same are in at this date, and abstain from the commission of waste on said premises until the note hereby secured is fully paid.

Seventh; that in case of default of any of the covenants or agreements herein contained, or in the note or notes secured hereby, the rents and profits of the said premises are pledged to the party of the second part as additional and collateral security for the payment of all the indebtedness secured hereby, and the said party of the second part is entitled to the passession of said property, by a receiver or otherwise, as it may elect. As additional and collateral security for the payment of the note and indebtedness hereinbefore desoribed, the said parties of the first part boreby usign to the said party of the second part all the profits, revenues, royalties, rights and benefits accruing or to accrue to them under all oil, gas mireral lenses on said premises, this assignment to terminate and become null and void upon the release of this mortgage by mortgage or assigns.

And the said parties of the first part, for said consideration do hereby expressly wrive all benefit of the exemption laws of the state in which the property is located.
