This indenture. Made this Twenty-eighth day of December in the year of our Lord nineteen hundred and twenty one by and between J. P. Cumpings, single; T. F. Cummings, single; J. F. Cummings, single; Mary E. Cummings, single. County of Douglas and State of Kansas, parties of the first part and The Central Trust Company, party of the second part;

Witnesseth, That the said parties of the first part, in consideration of the sum of Seventeen Hundred Dollars, to them in hand paid, the receipt whereof is hereby acknowledged, do by these presents Grant, Bargain, sell and convey unto the said party of the second part, its successors and assigns all of the following described real estate, situated in the County of Douglas and State of Kansas, towit The Northwest quarter of Section Twelve (12), Township twelve (12)

Range Eighteen (18), East of the Sixth (6) Principal Meridian, To have and to hold the same, with all and singular the hereditaments and appurtenances thereunto belonging or in anywise appertaining, and all rights of homestead exemption, unto the said party of the second part, and to its successors and assigns, forever. And the said parties of the first part do hereby covenant and are that at the delivery hereof, they are the lawful owners of the premises above granted, and seized of a good and indefeasible estate of inheritance therein, free and clear of all incumbrances, and that they will warrant and defend the same in the quiet and peaceable possession of said party of the second part, its successors and assigns, forever, against the lawful claims of all persons whomsoever.

Provided, always, and these presents are upon the following agreements. covenants and conditions. to wit:

First. That the parties of the first part are justly indebted to the party of the second part in the sum of Seventeen Hundred Dollars, according to the terms of one certain mortgage note of even date herewith, executed by said parties of the first part, in consideration of the actual loan of the said sum, and payable on the first day of January 1927, to the order of the said party of the second part with interest thereon at the rate of seven per cent per annum, payable semi-annually on the first days of January and July in each year, according to the terms of interest notes thereunto attached; both principal and interest and all other indebt edness accruing hereunder being payable in lawful money of the United States of America, at National Bank of Commerce, New York, N.Y., or at such other place as the legal holder of the principal note may in writing designate, and all of said notes bearing ten per cent interest after maturity.

Second. That the parties of the first part agree to keep all fences. buildings and improvements on the said premises in as good repair as they are at

the date hereof; to permit no waste of any kind; Third. That the perty of the second part may make any payments necessary to remove or extinguish any prior or outstanding title, lien or incumbrance on the premises hereby conveyed, and may pay any unpaid tuxes or assessments charged against said property, and may insure said property if default be made in the covenant to insure; and any sums so paid shall become a lien upon the above described real estate, and he secured by this Hortgage, and may be recovered, with interest at ten per cent.; in any suit for the foreclosure of this Hortgage. In case of foreclosure it is agreed that the judgment rendered shall provide that the whole of said real estate shall be sold together and not in parcels.

Fourth. That in case of default of any of the covenants or agreements herein contained, the rents and profits of the said premises are pledged to the party of the second part as additional and collateral security for the payment of all the indebtedness secured hereby, and the said party of the second part is entitled to the possession of said property, by receiver or otherwise, as it may elect.

Fifth. That the parties of the first part hereby agree to pay all taxes and assessments, general or special, excepting only the Federal Income Tax, which may be assessed in the State of Fansas upon the said land, premises or property, or upon the interest of the party of the second part, therein, and while this Hortgage s held by a non-resident of the State of Kansas upon this Mortgage or the debt becured thereby; without regard to any law heretofore enacted or hereafter to be enacted, imposing payment of the whole or any part thereof, upon the party of the second part, and that upon violation of this undertaking or the passage by the Become part, and that upon violation of this understaining or one passinge by the state of Kansas of a law imposing payment of the whole or any portion of any of the baxes aforesaid upon the party of the second part, or upon the rendering by any court of competent jurisdiction of a decision that the undertaking by the parties of the first part as herein provided, to pay any taxes or assessments is legally noperative, then, and in any such event, the debt hereby secured, without deduction shall, at the option of the party of the second part, become immediately due and collectible, notwithstanding anything contained in this Mortgage or any law hereafter enacted. The parties of the first part further agree not to suffer or permit 11 or any part of the taxes or assessments to become or remain delinquent, nor to ernit the said property or any part thereof, or any interest therein, to be sold for taxes, and further agree to furnish annually to the party of the second part, w n or before the tenth day of July the certificate of the proper authority, showing full payment of all such taxes and assessments.

Sixth. That the parties hereto further agree that all the covenants and agreements of the parties of the first part herein contained shall extend to and bind their heirs, executors, administrators, successors and assigns, and shall inure to the benefit of the party of the second part, its successors and assigns,
