

thence curving to the right with a radius of one hundred-fifteen and three-tenths (115.3) feet, a distance of one hundred-two and seven tenths (102.7) feet; thence on a tangent northwesterly one hundred nine and three-tenths (109.3) feet to the east line of Conklin Street; thence northly along the east line of Conklin Street thirty-one and two-tenths (31.2) feet to the place of beginning.
