installments, the first installment being due on May First A.D. 1923 and a like sum due semi-annually thereafter on the first day of May and November of each year according to the terms and conditions of said note, by which the entire principal and interest shall be fully paid, all on the amortization plan and in accordance with the amortization tabless provided by the Federal Farm Loan Board together with interest at the rate of eight per centsper annum on any installment of principal or interest or unpaid part of principal which shall not have been paid when due. Eoth principal and interest being payable at the office of KANSAS CITY STOCK LAND BANK, in hansas City, Mo.

If said mortgagors shall pay the aforesaid indebtedness, both principal and interst, according to the tenor of said note, as the same shall mature, and shall keep and perform all the covenants and agreements of this mortgage, then these presents to become oid; otherwise to remain in full force and effect;

Said mortgagors agree to pay all taxes and assessments that may be levied within the State of Kansas, upon said lands and tenements, or upon any interest or estate therein, including the interest represented by this mortgage lien; and further to pay any recording fee or tax, or assessment or charge that may be levied, assessed against or required from the holder of said mortgage and note as a condition to maintaining or enforcing or enjoying the full benefit of the lien of this mortgage, or the collection of the said indebtedness. The mortgagors agree to keep the buildings and imphovements upon said land in as good condition as they now are; to neither commit nor suffer waste; to maintain both fire and tornado insurance upon all buildings in a company satisfactory to the mortgagee or assigns, in a sum not less than Eighteen Hundred DOLLARS. payable in case of loss to mortgagee or assigns, upon the mortgage indebtedness, all insurance policies to be delivered unto mortgagee or assigns as soon as written, and by them retained until the payment of this obligation. insurance-fire, tornado, or both-should mortgagors defoult in so doing and to advance the money therefore; and to'repay such advances with interest at the rate of ten per centsper annum, mortgagors pledge themselves, and the lien of this mortgage shall extend thereto.

Said mortgagors hereby assign to KANSAS CITY JOINT STOCK LAND BANK all rents and incomes derived at any and all times from the property mortgaged to secure said note, and hereby authorize the said bank, at its option, to take charge of said property, collect and receipt for all rents and income, and apply the same on all payments, insurance premiums, taxes, assessments, repairs or improvements necessary to keep the property in tenable condition, or other charges provided for in said note, provided said amortization payments are inarrears. This assignment of rents and income to continue in force until the amount of this mortgage is fully paids

Nonpcompliance with any of the agreements made herein by mortgagors shall cause the whole debt secured hereby to mature at the option of the holder hereof, and no demand for the fulfillment of broken obligation or conditions, and no notice of election to consider the debt due shall be necessary before instituting suit to collect the same and foreclose this mortgage, the institution of such suit being all the notice required. The exercise of the rights and authority herein granted to the holder of the mortgage indebtedness to pay taxes, take out insurance, collect rents or performany other acts in case of default of mortgagors, shall be optional with the holder of siid mortgage indebtedness, and not obligatory upon him.
