This Indenture, Made this 10th day of September, A. D. 1923, between John A. Hess and Mary W. Hess, his wife, of Douglas County, in the State of Kansas, of the first part, and THE LAWRENCE BUILDING AND LOAN ASSOCIATION, of LAWRENCE, KANSAS, of the second part:

WITNESSETH: That the part ies of the first part, in consideration of the sum of Thirty-two Hundred and no/100 DOLLARS, the receipt of which is hereby acknowledged, do by these presents grant, bargain, sell and convey unto said party of the second part, its successors and assigns, all of the following described real estate, situated in the County of Douglas, and State of Kansas, to-wit: Lot Number Twelve (12) in Block Nine (9) in University Heights an addition to the City of Lawrence.

TO HAVE AND TO HOLD THE SAME, Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining, forever.

PROVIDED ALWAYS, And this instrument is executed and delivered to secure payment of the sum of Thirty-two Hundred and no/100 DOLLARS, with interest and premium thereon, and such fines and charges as may become due to said party of the second part under the terms and conditions of the contract note secured hereby, advanced by the said LAWRENCE BUILDING AND LOAN ASSOCIATION to the parties of the first part upon 32 shares of Class G of the capital stock of said Association, evidenced by Certificate No. 599 which said shares have been assigned to said Association with all future payments, earnings and dividends thereon, which said interest, premium and dues on said shares, the first parties agree to pay in monthly installments, making a total monthly payment of \$40.64, payable as follows forty and 64/100 Dollars, (\$40.64) on or before the last day of October, 1923, and a like sum on or before the last day of each and every month thereafter to and including the month of September, 1923.
