the receipt of which is hereby acknowledged, do by these presents grant, bargain, sell and convey unto said party of the second part,
its successors and assigns, all of the following described real estate, situated in the County of Douglas, and State of Kansas, to-wit:

conditions of the contract note secured hereby, advanced by the said THE Lawrence BUILDING AND LOAN ASSOCIA-
TION to the parties of the first part upon 11 shares of Class A of the capital stock of said Association, evidenced
by Certificate No. 632 which said shares have been assigned to said Association with all future payments, earnings and dividends
thereon, which said interest, premium and dues on said shares, the first parties agree to pay in monthly installments, making a total
monthly payment of \$13.97, payable as follows: Thirteen and 97/100 Dollars, (\$13.97) on or
before the last day of January 1924 and a like sum on or before the last day of each and every
month thereafter to and including the month of December 1933.
