This Indenture, Made this 28th day of August A. D. Nineteen Hundred and twenty-six
by and between G. C. Edmonds and Lena A. Edmonds, husband and wife,

in the county of Douglas and state of Kansas, part of the first part, and THE FARM MORTGAGE TRUST COMPANY, (incorporated under the laws of Kansas,) located at Topeka, Kansas, party of the second part:

WITNESSETH, that the said part of the first part, for and in consideration of the sum of One Thousand and no/100 Dollars to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do hereby MORTGAGE and WARRANT to the said party of the second part and to its legal representatives and assigns forever, all the following described tract or parcel of land, lying and situated in the county of Douglas and state of Kansas, to wit:

The North Half of the Southwest Quarter (1/2 Sec 4) of Section Two (2)

Township Twelve (12) south of Range Seventeen (17) East of the sixth

Principal meridian, containing 80 acres, more or less, according to the

Government Survey thereof,-----

To Have and to Hold the same, with appurtenances thereto belonging, or in any wise appertaining including any right of homestead and every contingent right or estate therein, unto the said

party of the second part, its successors or assigns forever: Provided, However, that if the said parties of the first part shall pay, or cause to be paid to the said party of the second part, its successors or assigns, the principal sum of One Thousand and no/100 Dollars on the first day of September A.D. 1931, with interest thereon at the rate of five per cent per annum, payable on the first day of March and September in each year, together with interest at the rate of ten per cent per annum on any installment of interest which shall not have been paid when due and on said principal sum after the same becomes due or payable according to the tenor and effect of a promissory note bearing even date herewith executed by the said parties of the first part and payable at the office of said company in Topeka, Kansas or such other place as the legal holder of the principal note may in writing designate, which note represents a just indebtedness and actual loan from the party of the second part to the parties of the first part; and shall perform all and singular the covenants herein contained, then this mortgage to be void and to be released at the expense of the said parties of the first part, otherwise to remain in full force and effect.
