WITNESSETH: That the said part ies of the first part, in consideration of the sum of _____ DOLLARS,
Twenty- six Hundred Fifty and no/100-----
 with interest thereon, and such fines and charges as may become due to said party of second part under the terms and conditions of the contract note secured
 hereby, advanced by the said The Lawrence Building and Loan Association to the part ies of the
 first part upon 26 1/2 shares of Class G of the capital stock of said Association, evidenced by Certificate No. 670, which said shares
 have been assigned to said Association with all the future payments, earnings and dividends thereon, which said interest and dues on said shares, the first part ies
 agree to pay monthly installments, making a total monthly payment of \$ 33.66, payable as follows:
-----Thirty-three and 66/100----- Dollars (\$ 33.66)
 on or before the last day of April, 1924, and a like sum on or before the last day of each and every
 month thereafter to and including the month of March, 1934.

An undivided Five- Sixths (5/6) of The North Forty-seven and One
 -Half (47 1/2) feet of Lot Number Forty-nine (49) on Louisiana
 Street in the City of Lawrence.

TO HAVE AND TO HOLD THE SAME. Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging or
 in anywise appertaining, forever.
