with interest thereon, and such fine and charges as may become due to said party of second part under the terms and conditions of the contract note secured hereby, advanced by the said The Douglas County Building and Loan Association to the purt. les. of the first part upon 20 shares of Class G of the capital stock of said Association, evidenced by Certificate No. 3221, which said shares have been assigned to said Association with all the future payments, earnings and dividends thereon, which said interest and dues on said shares, the first parties agree to pay monthly installments, making a total monthly payment of \$ 25.00 payable as follows:

Twenty Five and 40/100 Dollars (\$ 25.40) on or before the 29th day of September 1924, and a like sum on or before the 29th day of each and every month thereafter to and including the month of August 1924.
