S.L. Whitcomb and Edna Osborne Whitcomb, husband and wife

WITNESSETH: That the said part 108 of the first part, in consideration of the sum of
--Four Thousand and no/100 DOLLARS,
the receipt of which is hereby acknowledged, do by these presents grant, bargain, sell and convey, unto said party of the second part, its successors and assigns, all of the following described real estate, situated in the County of Douglas, State of Kansas, to-wit:

Lots Numbers One (1) Two (2) and Three (3),
in Block Number Eight (8) in University Place, an Addition
to the City of Lawrence,

TO HAVE AND TO HOLD THE SAME, Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, forever.

PROVIDED ALWAYS, And this instrument is executed and delivered to secure the payment of the sum of
--Four Thousand and no/100-- DOLLARS,

with interest thereon, and such fines and charges as may become due to said party of second part under the terms and conditions of the contract note secured hereby, advanced by the said The Lawrence Building and Loan Association to the part 108 of the first part upon 40 shares of Class G of the capital stock of said Association, evidenced by Certificate No. 764, which said shares have been assigned to said Association with all the future payments, earnings and dividends thereon, which said interest and dues on said shares, the first part 108 agree to pay monthly installments, making a total monthly payment of \$82.80, payable as follows:

Eighty-two and 80/100 Dollars (\$82.80)
on or before the last day of November, 1924, and a like sum on or before the last day of each and every month thereafter to and including the month of October 1929.
