WITNESSETH: That the said part ies of the first part, in consideration of the sum of DOLLARS,
Fifteen Hundred and no/100---
hereby, advanced by the said The Lawrence Building and Loan Association to the part ies of the
first part upon 15 shares of Class G of the capital stock of said Association, evidenced by Certificate No. 779, which said shares
have been assigned to said Association with all the future payments, earnings and dividends thereon, which said interest and dues on said shares, the first part ies
agree to pay monthly installments, making a total monthly payment of \$ 19.05, payable as follows:
Nineteen and 15/100--- Dollars (\$ 19.05)
on or before the last day of November, 1924, and a like sum on or before the last day of each and every
month thereafter to and including the month of October 1934.

The West One-half (1/2) of Lot Number One Hundred Fifteen (115)
and all of Lot Number One Hundred Seventeen (117) all on Dear-
horn Street in Baldwin City.

TO HAVE AND TO HOLD THE SAME. Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging or
in anywise appertaining, forever.

PROVIDED ALWAYS, And this instrument is executed and delivered to secure the payment of the sum of DOLLARS,
Fifteen Hundred and no/100---
with interest thereon, and such fines and charges as may become due to said party of second part under the terms and conditions of the contract note secured
hereby, advanced by the said The Lawrence Building and Loan Association to the part ies of the
first part upon 15 shares of Class G of the capital stock of said Association, evidenced by Certificate No. 779, which said shares
have been assigned to said Association with all the future payments, earnings and dividends thereon, which said interest and dues on said shares, the first part ies
