THIS INDENTURE, Made this 8th day of August A.D. 1927, between George W. Jones and his wife Jessie Jones of Douglas County, in the State of Kansas, of the first part, and The Douglas County Building and Loan Association of Lawrence, Kansas, of the second part.
WITNESSETH: That the said parties of the first part, in consideration of the sum of Thirty Hundred and no/100 DOLLARS, the receipt of which is hereby acknowledged, do by these presents grant, bargain, sell and convey, unto said party of the second part, its successors and assigns, all of the following described real estate, situated in the County of Douglas, State of Kansas, to-wit:

The north 25 feet of the east 181.2 feet (Less the east 50 feet thereof, said east 50 feet being deeded to Douglas County for a street) of Lot eight (8) in Block four (4), in South Lawrence an Addition to the City of Lawrence, Also the south 25 feet of the east 181.2 feet (less the east 50 feet thereof, said East 50 feet being deeded to Douglas County for a street) of Lot seven (7) in Block four (4) in South Lawrence, an addition to the City of Lawrence.

TO HAVE AND TO HOLD THE SAME, Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, forever.

PROVIDED ALWAYS, And this instrument is executed and delivered to secure the payment of the sum of Thirty Hundred and no/100 DOLLARS, with interest thereon, and such fines and charges as may become due to said party of second part under the terms and conditions of the contract note secured hereby, advanced by the said The Douglas County Building and Loan Association to the parties of the first part upon 30 shares of Class G of the capital stock of said Association, evidenced by Certificate No. 3421, which said shares have been assigned to said Association with all the future payments, earnings and dividends thereon, which said interest and dues on said shares, the first party of the first part agree to pay monthly installments, making a total monthly payment of \$ 38.10, payable as follows: Dollars (\$ 38.10) on or before the 8th day of August 1927, and a like sum on or before the 8th day of each and every month thereafter to and including the month of July 1937.

Now, if said party of the first part shall cause to be paid to the party of the second part the amount due it under said contract note, in accordance with the terms thereof, and comply with all the provisions and agreements in said note contained, then these presents shall be void; otherwise in full force and effect, and may be foreclosed as in said contract note provided.
