PROVIDED ALWAYS, And the instrument is recorded and filed to secure the payment of the sum of

DOLLARS,

with interest thereon, and such taxes and charges as may become due to said party of second part under the terms and conditions of the contract note secured
 hereby, advanced by the said The Lawrence Building and Loan Association to the part ies of the
 first part upon five shares of Class G of the capital stock of said Association, evidenced by Certificate No. 1274, which said shares
 have been assigned to said Association with all the future payments, dividends and interest thereon which said interest and shares on said shares, the first
 parties agree to pay monthly commencing on the first day of September 1927, in a sum of \$ 6.35 payable as follows:

Six and 35/100 last day of October 1927 and a like sum on or before the last day of each and every
 month thereafter to and including the month of September 1937.

Now, if said part ies of the first part shall come to be paid to the party of the second part the amount due under said contract note, in accordance
 with the terms thereof, and comply with all the provisions and agreements in said note contained then these presents shall be void; otherwise in full force
 and effect, and may be foreclosed as provided in said note provided.
