This Indenture made this 17 day of November in the year of our Lord one thousand eight hundred and eighty three by and between M. B. Pryor and Maggie Pryor his wife of the County of Douglas and State of Kansas parties of the first part and Hugh Bryson of the County of Johnson and State of Kansas party of the second part;

Witnesseth that the said parties of the first part in consideration of the sum of One Thousand Dollars to them in hand paid the receipt whereof is hereby acknowledged does by these presents grant bargain sell and convey unto the said party of the second part and to his heirs executors administrators and assigns all of two certain parcels of land or real estate situated in the County of Douglas and State of Kansas and more particularly bounded and described as follows to wit;

The East half of the South East quarter of Section No. Thirty two, Township No. Fourteen, Range Twenty one, also the West half of the South West quarter of Section No. Thirty three in Township No. Fourteen of Range Twenty one. To have and to hold the said described premises together with all rights and claims of Homestead Exemption of the said parties of the first part their heirs executors administrators or assigns therein with all the privileges rights hereditaments and appurtenances to the said premises and homestead exemption in anywise appertaining and belonging to the only proper use and benefit of the said party of the second part his heirs executors administrators and assigns forever;

Provided nevertheless And these presents are made expressly upon condition as follows to wit; That whereas the said M. B. Pryor and Maggie his wife are justly indebted to the party of the second part in the sum of One Thousand Dollars according to the tenor and effect of one certain promissory note executed by the said M. B. Pryor and Maggie Pryor his wife of even date herewith and payable one year after the date thereof to the order of the said party of the second part in the aforesaid sum of money for value received with interest thereon at the rate of eight per cent per annum from the date of the said promissory note interest annually on the 17th
