in anywise appertaining, forever.

PROVIDED ALWAYS, And this instrument is executed and delivered to secure the payment of the sum of

Thirty seven Hundred and no/100

DOLLARS,

with interest thereon, and such fines and charges as may become due to said party of second part under the terms and conditions of the contract note secured  
hereby, advanced by the said The Douglas County Building and Loan Association to the part 188 of the  
first part upon 37 shares of Class G of the capital stock of said Association, evidenced by Certificate No. 3473, which said shares  
have been assigned to said Association with all the future payments, earnings and dividends thereon, which said interest and dues on said shares, the first part 188  
agree to pay monthly installments, making a total monthly payment of \$ 46.99, payable as follows:

on or before the 18th day of January, 1928, and a like sum on or before the 18th day of each and every
