WITNESSETH: That the said part 1es of the first part, in consideration of the sum of

Twenty-five Hundred and No/100

DOLLARS,

the receipt of which is hereby acknowledged, do by these presents grant, bargain, sell and convey, unto said party of the second part, its successors and assigns, all of the following described real estate, situated in the County of Douglas, State of Kansas, to-wit:

West Thirty-seven and one-half (37½) feet of Lot One Hundred Thirteen (113) and
the East One-half (½) of Lot One Hundred Sixteen (116) on Indiana St. in Baldwin
Kansas.

TO HAVE AND TO HOLD THE SAME, Together with all and singular, the tenements, hereditaments and appurtenances thereunto belonging or
in anywise appertaining, forever.

PROVIDED ALWAYS, And this instrument is executed and delivered to secure the payment of the sum of

Twenty-five Hundred and No/100

DOLLARS,

with interest thereon, and such fines and charges as may become due to said party of second part under the terms and conditions of the contract note secured
hereby, advanced by the said The Lawrence Building and Loan Association to the part 1es of the
first part upon 25 shares of Class G of the capital stock of said Association, evidenced by Certificate No. 1691, which said shares
have been assigned to said Association with all the future payments, earnings and dividends thereon, which said interest and dues on said shares, the first part 1es
agree to pay monthly installments, making a total monthly payment of \$ 31.75, payable as follows: Thirty-one and 75/100

on or before the last day of August, 1931, and a like sum on or before the last day of each and every
month thereafter to and including the month of July, 1941.

Now, if said part 1es of the first part shall cease to be paid to the party of the second part the amount due it under said contract note, in accordance
with the terms thereof, and comply with all the provisions and agreements in said note contained, then these presents shall be void; otherwise in full force and
effect, and may be foreclosed as in said contract note provided.
