

Parcel No. 85. Bexar County.

Lot Twenty-two (22), Block Seventy-three (73) Keystone Park Addition, New City Block Twenty-seven Hundred and Sixty-eight (2768), in the City of San Antonio, Bexar County, Texas, fronting fifty (50) feet on the North line of Rosewood Avenue, four hundred and fifty (450) feet west from the West line of Brad Avenue, and extending North between parallel lines one hundred and twenty (120) feet.

Parcel No. 86. Bexar County.

Lots Eleven (11) and Twelve (12), Block Twenty-seven (27) Laurel Heights Addition, New City Block Eighteen Hundred and Forty-three (1843), situated on the Northeast corner of the intersection of West Woodlawn Avenue and the I. & C. N. R. R.

Lots Twenty-three (23) and Twenty-four (24), Block Eight (8), Beacon Hill Addition, New City Block Seventeen Hundred and Eighty (1780) in the City of San Antonio, Bexar County, Texas, fronting fifty (50) feet on the South line of Fulton Street and running South one hundred and twenty-five (125) feet along the West line of the Blanco Road to an alley.
