THIS INDENTURE made as of this 14th day of October A. D. 1929 by and between the Old Colony Trust Company, a Massachusetts corporation, having its principal office in the City of Boston, County of Suffekk State of Massachusetts, as Trustee, party of the first part, and the Southrestern Bell Telephone Company, a duly organized and existing Missouri corporation (formerly known as The Mis-ouri and Kansas Telephone Company,) as party of the second part. WITNESSETH:

WHEREAS, The Missouri and Kansas Telephone Company did, on December 29, 1916, change its name to the Southwestern Bell Telephone Company; WHEREAS, said The Missouri and Kansas Telephone Company did, execute its certain First Mortgage deed

of trust, dated October 2, 1899, conveying all of its property, real and personal, to the Old Colony Trust Company, as Trustee, to secure \$1,250,000 Five Per Cent (5%) Bonds of said The Missouri and Kansas Tele-phone Company;

HIERAS, by a second indenture also dated October 2, 1899, said The Missouri and Kansas Teleph Company and the Old Colony Trust Company jointly, and as a supplement to the indenture hereinbefore described conveyed the trust premises in each first described indenture to one James A. Parker to secure the payment of said bonds, and subject to the provisions of said first described indenture:

WHEREAS, By a third indenture also dated October 2, 1899 said James A. Parker, conveyed the trust premises hereinbefore described to the Old Colony Trust Company and Charles J. Hubbard, as trustees, wi

premises mereineerore described to the Old Colony Trust Company and Charles J. Anddard, as trustees, with and subject to the powers and provisions contained in said first described indexture: WHEERAS, subsequent to the execution of said, three indentures hereinbefore described, certain supplemental indentures were from time to the executed by said The Missouri and Kanas Telephone Company, or by said Southwestern Bell Telephone Company after the charge of name, which supplemental indentures, among other things conveyed additional items of corporate property in trust to said Old Colony Trust Company and Charles J. Bubbard, trustees, under the terms and provisions of said first described and principal infectures. indenture: and.

THEREAS, by virtue of said three hereinbefore described indentures and the several supplements thereto there were created certain trusts as to the property real and personal of The Missouri and Kansas Telephone Company (now of the Southwestern Bell Telephone Company) to secure certain indebtedness thereof, represented by said bonds, which indebtedness has been fully and finally satisfied and discharged by said Southwestern Telephone Company, by reason of which said party of the second part is now entitled to have the life and encumbrance of said trust so created, satisfied and discharged in accordence with the provisions of Articles Eleven and Televe of said principal First Wortgege trust indenture hereinbefore described by the party of the first part as Trustee under the powers vested in said party to sat for both trustees under paragraph 2 of said third indenture hereinbefore described. NON THEREFORD, in consideration of the premises and the sum of One Dollar (\$1.00) to the party of the first part in hend party of the second part; the receipt wherd in hereby acknowledged, said party of the first part as Trustee does by these presents remise, release and forever quitchin unto the said party of the second part; to encuebered by said indentures of mortgage or any of them, or by any supplements thereto, and does hereby forever release and discharge said mortgage deeds of trust and supplements thereto and the liens thereby carchard. TO HAYE AND TO HOLD the same with all the rights, immunities, privileges and appurtenances thereto THEREAS, by virtue of said three hereinbefore described indentures and the several supp

TO HAVE AND TO HOLD the same with all the rights, immunities, privileges and appurtenances therety belonging unto the said party of the second part and unto its successors and assigns forever, so that none of said trustees, nor their heirs, successors or assigns, or any other person or persons, firms, associations or corporations for them or in their names or behalf either individually or jointly shall or will, hereafter claim or demend any right or title to the aforesaid premises or any part thereof for themselves or the bondholders which they represented as such trustees, but they and every one of them

themselves or the boncholders which they represented as such status, and they due only due of the shell by these presents be excluded and forever barred.
