EXTENSION AGREEMENT AND COUPONS.

WHEREAS, The Fraternal Aid Union the owner of a certain mortgage note of Thirty-five hundred, reduced to Three Thousand Dollars (\$3,000.00) given by Kans. Univ. Endowment Ass'n to The Fraternal Aid Union dated October 5, 1923 and secured by mortgage recorded in book 63 of mortgages, at page 216 in the office of Register of Deeds of Douglas County, Kansas, has agreed to extend the time of payment of said note to October 5, 1934. 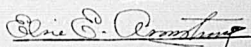
