EXTENSION AGREEMENT AND COUPONS.

Lawrence, Kansas, September 28, 1931

WHEREAS, The Fraternal Aid Union the owner of a certain mortgage note of Twenty-seven hundred, reduced to Twenty-five hundred Dollars (\$2500.00) given by E. W. Schafstall & Anna E.
