

EXTENSION AGREEMENT

WHEREAS, There remains unpaid on a certain note executed and delivered to SOUTHWEST MORTGAGE CO., by JOHN A. REEDER and CORDIA C. REEDER, his wife, secured by a mortgage upon real estate in DOUGLAS County, Kansas, dated September 1, 1926 and recorded in said County on September 28, 1926 in Volume 57 of mortgages, on Page 433, the sum of TWO THOUSAND FIVE HUNDRED and NO/100 Dollars, with interest from February 1, 1932, and;

WHEREAS, Title to the mortgaged premises is now vested in JOHN A. REEDER and CORDIA C. REEDER, his wife subject to said mortgage and;

WHEREAS, The holder of said mortgage debt has been requested to make said note and mortgage payable as hereinafter agreed, which the owner and holder of said note and mortgage has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, The said JOHN A. REEDER and CORDIA C. REEDER, his wife, as owners, and J. R. REEDER, as Guarantor hereby agree to pay interest on the said sum of TWO THOUSAND FIVE HUNDRED and NO/100 Dollars from the first day of February 1932, to the first day of February 1937, according to the tenor and effect of interest coupons of even date herewith, and executed by the makers hereof in connection herewith, and to pay the principal sum remaining as aforesaid as follows:- \$100.00 due on each FEBRUARY 1, 1933, 1934, 1935, 1936 and the balance of \$2100.00 due FEBRUARY 1, 1937 with the privilege of paying One Hundred Dollars, or any multiple thereof, on said principal sum on any interest pay day on or after the first day of February 1933.

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
