PARTIAL SATISFACTION OF MORTGAGE

THIS INDENTURE, Made this 29th day of September 1932, between The Board of Home Missions and Church Extension of the Methodist Episcopal Church, formerly The Board of Church Extension of the Methodist Episcopal Church, incorporated under the laws of the State of Pennsylvania, party of the first part, and the First Methodist Episcopal Church of Baldwin City County of Douglas State of Kansas party of the second part;

WHEREAS, The said party of the second part, by indenture of mortgage bearing date October 21st 1931, and recorded November 9th 1931, in Book No. 77 of Mortgages at page 384, for the consideration therein mentioned, did convey certain lands and tenements, of which the land hereinafter described is part, unto the said party of the first part;

AND WHEREAS, The said party of the first part, at the request of the said party of the second part, has agreed to give up and surrender the land hereinafter described unto the said party of the second part, and to hold and retain the residue of the mortgaged lands;
